We want to be protected by the blood of Christ when our names come up in the judgment.

NOTE: Whereas judgment is totally deserved, totally warranted. Forgiveness is offered to all, but it is given only to those who cease their rebellion against the Lord and return to him. While probationary time lasts, Christ is willing to accept and win our case at court, but only if, in humility of heart with simple childlike submission and obedience, we let Him remove our sins and purify our hearts.

Fiery Serpent [Numbers 21:4-10] •

NOTE: Moses was divinely commanded to make a serpent of brass resembling the living ones, and to elevate it among the people. All who had been bitten were to look, and they would find relief. If these people, though faint and dying, could only once look upon the serpent they were perfectly restored.

"All have sinned and come short of the glory of God." Like sheep have gone astray. God's invitation is, "Look unto me," the Saviour on the cross with outstretched hands says, "Look unto Me and be you saved all you ends of the earth."

Jesus used the brazen serpent to illustrate how people are saved. [See John 3:14, 15] "As Moses lifted up the serpent so must the Son of man be lifted up: that whosoever believes in Him should not perish, but have everlasting life."

One moment he was dying; the next minute by simply looking at the brazen serpent, he was completely healed. So the very moment you give yourself to Jesus and take Him as the One who bled and suffered for you, you are pardoned and saved.

**NOTE:** When we become children of God, our names are written in the Lamb's book of life, and they remain there until the time of the investigative judgment. Then the name of every individual will be called, and his record examined, by Him who declares, "I know thy works." If in that day it shall appear that all our wicked deeds have not been fully repented of, our names will be blotted from the book of life, and our sins will stand against us.

Every deed of heartfelt kindness to others is to be found in this book of God's remembrance. There every temptation resisted, every evil overcome, every word of tender pity expressed, is faithfully kept. And every act of sacrifice, every suffering and sorrow endured for Christ's sake is recorded.

**NOTE:** God does not need to keep books for Himself, but rather they are kept for others who do not have His omniscience. These books are available to the heavenly hosts in the court for their investigation that they may know that God is just.

The work of the investigative judgment and the blotting out of sins is to be accomplished before the second advent of the Lord.

As the books of record are opened in the judgment, the lives of all who have believed on Jesus come in review before God. Beginning with those who first lived upon the earth, our Advocate presents the cases of each successive generation, and closes with the living. Every name is mentioned, every case closely investigated. Names are accepted, names are rejected.

When any have sins remaining upon the books of record, unrepented of and unforgiven, their names will be blotted out of the book of life, and the record of their good deeds will be erased from the book of God's remembrance.

All who have truly repented of sin, and by faith claimed the blood of Christ as their atoning sacrifice, have had pardon entered against their names in the books of heaven... their sins will be blotted out, and they

themselves will be accounted worthy of eternal life. Sins that have not been repented of and forsaken will not be pardoned and blotted out of the books of record, but will stand to witness against the sinner in the day of God. [Great Controversy, 483]

NOTE: Everyone's fate will have been decided by the court of heaven before the second coming of Jesus, and nothing will change the verdict after the pre-advent investigative judgment of the saints has concluded (the close of probation). While only the books regarding the saints of God have been examined in the preadvent investigative judgment, the wicked stand condemned by not having sought the defense of the righteousness of Jesus Christ, so their sins are not covered by Christ's righteousness, and they must bear responsibility for their own sins.
